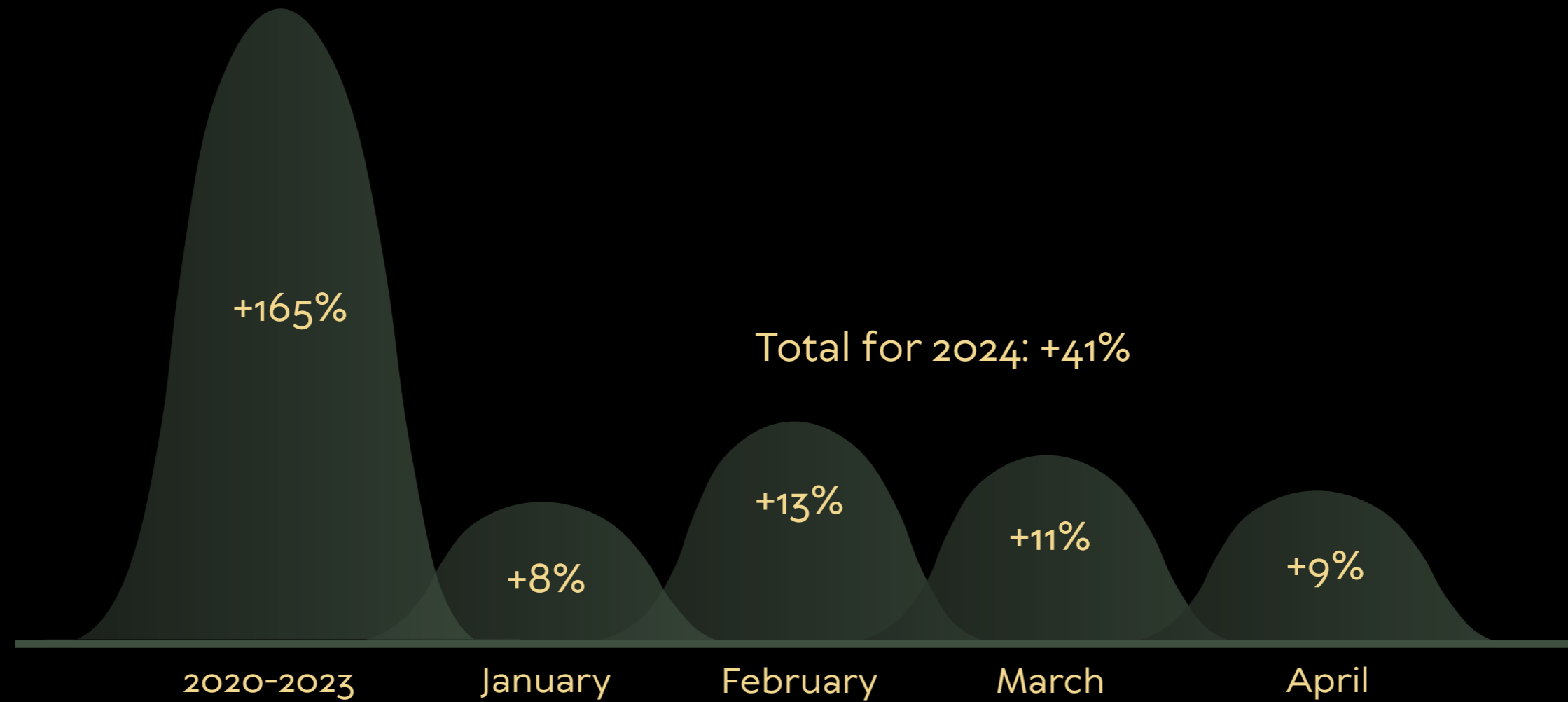

THE FUND IS OWNED BY TWO ENTHUSIASTS AND EXPERTS IN CRYPTOCURRENCIES, ENTREPRENEURS, AND SPECIALISTS IN MARKETING AND IT. 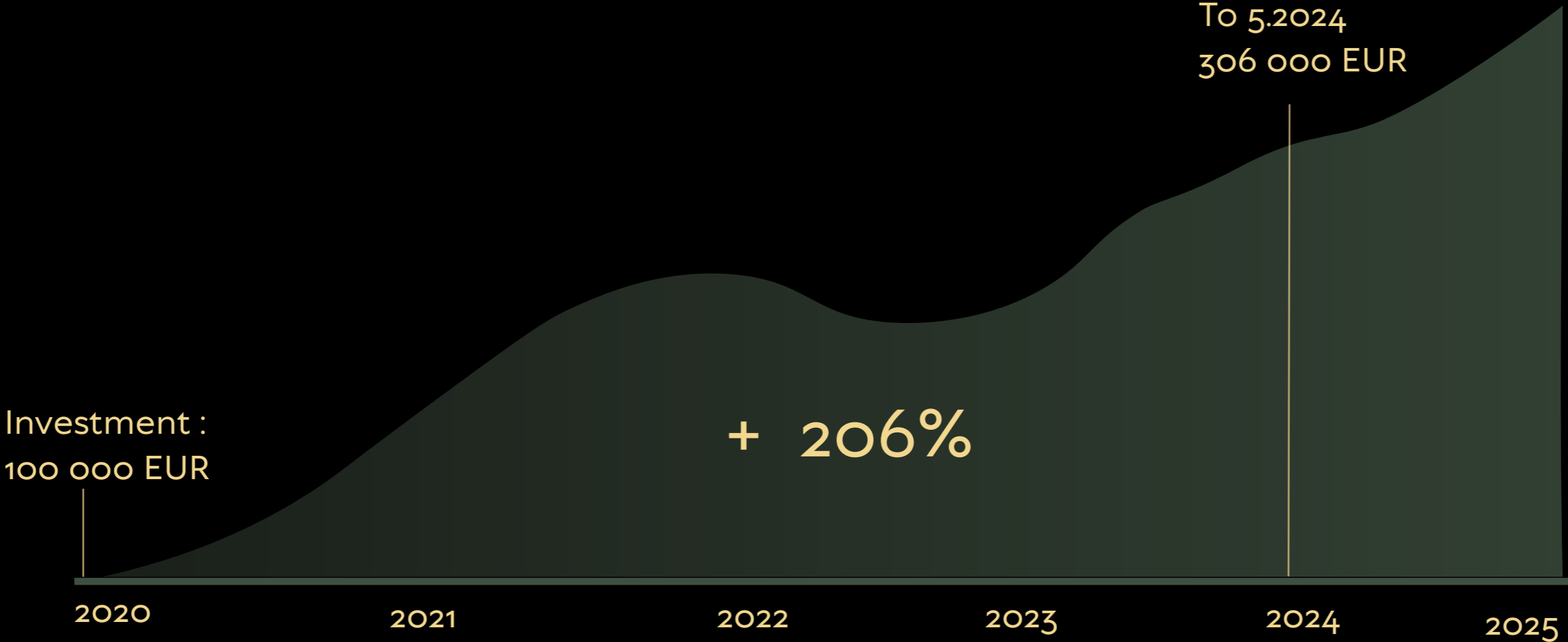

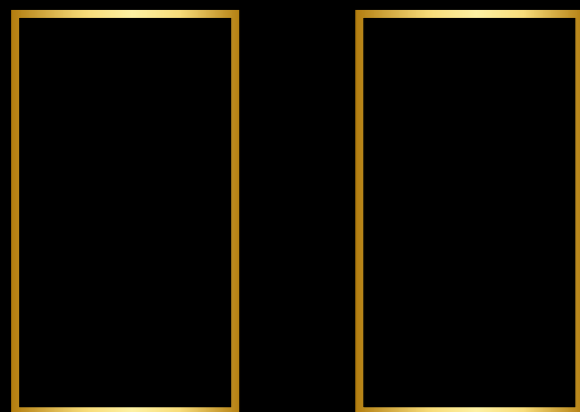

HOW THE SOFTWARE TRADES

THE SOFTWARE FOCUSES ON SHORT-TERM PREDICTIONS OF BITCOIN, ETHEREUM, AND POTENTIALLY OTHER INTERESTING DIGITAL CURRENCIES, WITHIN A HORIZON OF 30 MINUTES TO 4 HOURS. ALL OF THIS OCCURS ON THE WORLD'S LARGEST CRYPTO EXCHANGES WITH MAXIMUM DATA AND FINANCIAL PROTECTION. BASED ON ONGOING ANALYSES CONDUCTED EVERY MINUTE, THE ROBOT DECIDES WHETHER TO BUY, SELL, OR CONTINUE HOLDING A GIVEN CURRENCY.

SECURITY

EXCHANGES

WE ONLY SELECT EXCHANGES WHERE GREAT EMPHASIS IS PLACED ON THE SECURITY OF STORED FINANCIAL ASSETS. THESE ARE THE WORLD'S LARGEST EXCHANGES WITH THE HIGHEST SECURITY SYSTEMS AND PROTECTION. CONNECTION TO THE EXCHANGES IS HANDLED VIA API (APPLICATION PROGRAMMING INTERFACES) WHICH DO NOT ALLOW WITHDRAWALS FOR GREATER SECURITY.

DATA

THE ENTIRE TEAM HAS ACCESS TO ALL DATA AND FILES PROTECTED BY 2FA VERIFICATION. DUAL AUTHENTICATION DURING LOGIN USING A CODE ON THE PHONE OR FACE RECOGNITION VERIFICATION.
